
Sample of Complex Maritime Cases – Suitable for Adhoc Arbitrations





Issues Related to P & I and Insurance Claims



- Insurance Covers: Only covers, if "caused by" List of Causes
- Exclusion Clauses: Review the losses / liability excluded if caused by a "List of Causes Excluded"



Brief Overview of Making and Receiving Insurance Claims


Offshore energy gross loss ratios – Europe*
